什麼是「平均成本法」?

「平均成本法」是一項紀律化的長線投資策略。透過這方式,無論市況如何,您都會以固定的金額作出定期投資於同一個投資項目,例如每月供款\$1,000港元。當價格偏低時,您所投資的固定金額會為您購入較多的基金單位;而當價格偏高時,您則會購入較少的基金單位。長線而言,您的平均投資成本便相對減低。

由於職業退休計劃是以每月供款形式投資,「平均成本法」回報更能反映您的情況,因此 我們為您準備了以上的圖表,以顯示在不同時段的「平均成本法」回報。舉例您在1年前 開始供款,您便可從1年表現一欄找到1年的「平均成本法」回報。

What is Dollar Cost Averaging?

"Dollar Cost Averaging" ("DCA") is a disciplined approach to long-term investing where you invest a fixed amount of money, for example HK\$1,000 per month regardless of the market situation. With this approach, you therefore buy more units when the prices are low and buy less when the prices are high. Over the long-run, your average investment cost is lowered.

As ORSO is a monthly contribution, the DCA return can therefore better reflect your situation. That's why we have prepared the above table to show you the DCA returns for different time periods. For instance, if you started your contribution to the Scheme one year ago, you may refer to the 1 year performance column for the DCA return.

Remark:

DCA returns are calculated based on the assumption that a fixed amount of money is invested in the same fund on the last business day of every month. There is no initial transferred-in asset or asset switch during the investment period.

特朗普勝選提振投資者情緒,進而帶動美股上 漲。標準普爾500指數、羅素2000指數和納斯達 克指數等主要指數均表現理想。按當地貨幣計, 歐洲股票於11月份小幅上漲。歐元區整體通脹從 10月份的2.0%升至11月份的2.3%。這與預期 致,幾乎完全是由於能源通脹上升引發的基數效 應所致。亞太區股市錄得負回報,指數佔比較高 的中國市場表現欠佳。台灣和南韓因近期的美國 總統選舉 (前任總統特朗普重新掌權) 而受到負 面影響。特朗普的貿易保護主義政策料會對亞洲 的主要經濟合作夥伴造成影響。


US stocks gained as Donald Trump's election victory boosted investor sentiment. Major indices like the S&P 500, Russell 2000, and Nasdaq performed well. European equities made small gains over November in local currency terms. Eurozone headline inflation rose from 2.0% in October to 2.3% in November. This was in line with expectations and was almost entirely caused by a baseeffects driven increase in energy inflation. Asia Pacific equity markets delivered negative returns with index heavyweight China underperforming. Taiwan and Korea were negatively impacted by the recent US presidential election, which will see former President Donald Trump return to office. His protectionist policies are expected to impact key economic partners in Asia.

Government bond markets had a strong month, especially in Europe, with investors anticipating faster European Central Bank (ECB) rate cuts. The Federal Reserve (Fed) cut rates by 25bps to 4.5%-4.75%, and UK rates fell to 4.75%. As expected, the Fed cuts rates by 25bps but Donald Trump's presidential victory raises concerns over the inflationary aspect of tariffs. Markets responded by pricing in a slower pace of interest rate cuts in 2025. It was a positive month for corporate bond markets. In a sign of growing investor confidence, corporate bonds spreads for US investment-grade (IG) fell to an all-time low of 77bps during November before closing the month at 83bps. The spread for sterling IG also narrowed, moving from 107bps to 103bps although the spread for euro IG widened from 105bps to 107bps.


聯儲局於11月份的聯邦公開市場委員會會議上 再次下調政策利率25點子。月初,市場因應宏觀 經濟數據放緩幅度不及預期,以及特朗普即將 上任引發的通脹和財政憂慮而重新定價,導致美 國國庫券全線遭到拋售,但隨後美國財政部長的 任命安撫市場情緒,加上擬議中的墨西哥/加拿 大/中國關稅與特朗普2.0時代廣泛的貿易與移 民焦點預期一致,推動市場上漲。聯儲局於11月 份減息後,香港金融管理局亦將基本利率下調25 點子至5%。截至月底,港元2年期債券利率拓闊 17點子,5年期債券利率升4點子。

The Federal Reserve (Fed) further cut its policy rate by 25bps at November's Federal Open Market Committee (FOMC) meeting. US Treasury was sold off across the curve early the month when the market repriced on less weak than expected macro data, inflationary, and fiscal concerns from incoming Trump administration, while rallied later the month when the US Treasury Secretary nomination comforted markets and the mooted Mexico/Canada/China tariffs were in-line with expectations of a broader trade and immigration focus in Trump 2.0. HKMA reduced the base rate by 25bps to 5% following the Fed cut in November. HKD2-Year rates widened by 17bps and 5-Year was 4bps higher by the month end.
